Thank you for your letter of 22nd May 2009. I have checked the Legal Services Act 2004 and there appears to be no provision under that Act for the Legal Services Commissioner to accept complaints let alone serious allegations against Judges or to act as intermediary in relation to criminal allegations against barristers and lawyers. Her role appears to be limited to civil complaint and possible disciplinary complaints.

I also understand that I may provide information and evidence of a perceived criminal act against any citizen and it is not necessary for me to have a go-between or intermediary.

I therefore reassert my allegations against Justice Osborne and the lawyers named in my letter of 6th May 2009.

In summary I say that the lawyers named in my letter of 6th May 2009 conspired with one another to misrepresent both fact and law for the purpose of wrongfully obtaining judgment in favour of their clients and that subsequently Justice Osborn had full knowledge of the fact of those misrepresentations and he fabricated his Reasons for Judgment in such a manner as to ignore, deny, conceal and/or otherwise make wrong the fact, known to him, that the lawyers had misrepresented both fact and law.

My specific allegation against the lawyers and Justice Osborn is that they each acted in such a manner as to pervert the course of justice and in the case of the lawyers that they conspired with one another for that purpose. On my understanding these things constitute criminal allegations and the proper authority to receive and deal with such allegations is the Victoria Police.

On my understanding Justice Osborn is not immune from such allegations or inquiry into such allegations. If true he was not acting as a Judge when he did the things giving rise to my allegations, he was acting in breach of his oath and outside his authority.

On the **Lying Lawyers** page of that website you will find evidence that the lawyers named in my letter of 6th May conspired with one another to misrepresent both the law and the facts in respect to matters relating to section 9 of the Sale of Land Act 1962 and that they conspired with one another to conceal their intention to make those misrepresentations.

On the **Teaser** page you will find evidence that the named layers misrepresented a purported agreement between the then Kyneton Water Board/Trust and the timeshare company Woodleigh Heights Resort Developments P/L as being a lawful and enforceable agreement when they knew full well it was in fact unlawful, unenforceable and had been entered into for fraudulent purpose, namely to unlawfully prevent the sale of land owned by me to any entity other than the timeshare company or associated entities.

On the **Osborn pages** you will find evidence that Justice Osborn was fully aware of the misrepresentations of these lawyers and that in knowledge of these misrepresentations and that the lawyers had wrongfully obtained a judgment based on those misrepresentations he fabricated/constructed his Reasons for Judgment in the face of the law and the facts known to him and the effect was to ignore, deny, conceal and/or otherwise make wrong the further fact known to him that the lawyers had misrepresented the law and the facts.

In the assumption that lawyers and judges are not above the law as applied to other citizens my expectation is that the Victoria Police will consider the evidence before dismissing me.

For the purpose of brief example of the grounds for my allegations I set out the following.

With the greatest respect, the simple fact is that both you and I know full well that there is no possible lawful means whereby you could gain control over the water supply, or any other essential service, to someone else's property and then deny them access to that essential service for the purpose of forcing that other person to sell his property to you at less than market value.. The fraud which was perpetrated against my family and I depended upon the Macedon Ranges Shire Council and Coliban Water (by their predecessors and as presently constituted) falsely representing that such a Water Supply Agreement was lawful and enforceable. This misrepresentation has been consistently represented over the past 25 years and was most recently represented in the court before Justice Osborn by a Major General Greg Garde QC.

On the material set out on the website, as a matter of common sense, let alone law, Justice Osborn was fixed with knowledge that the representations of Mr. Garde were misrepresentations. In addition I specifically alleged that the representations of Garde were misrepresentations. In knowledge of these things Justice Osborn constructed his Reasons for Judgment in such a manner as to hold that the timeshare company did control the water supply and did deny my access to water and not hold that the Water Supply Agreement was unlawful. By doing so Justice Osborn did effectively ignore, deny, conceal and/or make wrong the fact known to him that Greg Garde had misled the court and previous courts.


On the evidence set out on the website, in order to facilitate his Reasons in relation to the Water Supply Agreement Justice Osborn's Reasons fly in the face of further facts and law manifestly known to him. His Reasons are carefully constructed to facilitate his ignore and denial of the misrepresentations of the lawyers.

Please do not dismiss me lightly, the facts are on the website and I have made those facts available to you. I have not done so lightly.

I say that on the evidence available to you it is not possible that Justice Osborn held a reasoned or judicial belief as to his Reasons for Judgment.

I had already made appropriate complaint to the Legal Services Commissioner. This information and allegation is made to the Victoria Police.
